Sub: - Open Selection trial and camp for upcoming Santosh Trophy 2021-22.

This has reference to the above-mentioned subject. We, wish to inform you that DNH FA will be conducting fair and open selection trials for the upcoming Santosh Trophy team from at the **Silvassa Stadium football Ground**. Trials will be held under the following guidelines & Players are hereby requested to read it thoroughly to avoid failure & misconception.

Guidelines to be followed to attend Santosh Trophy Trials 2021-22.

- Players Attending trials must be fully vaccinated with Double Dose of Vaccination having certificate of the same approved by Government of India.
- Players who are born on or after **1st January 2002** and have completed **18 years of age** and are fully vaccinated at the time of registration are eligible to attend trials by submitting following documents mentioned below.
- Player attending trials must note that he is not registered in more than two clubs in the year 2020-21, Players registered in more than two clubs will be rejected & not eligible to participate in NFC Santosh Trophy.
- Players falling in the above eligibility criteria are requested to send the following original documents on **Registration@dnhfa.com** mentioned below in Scanned PDF format.
- **DATE OF BIRTH CERTIFICATE** (Certified by Concerned Municipality of District or State)
- **AADHAR CARD COPY FRONT & BACK** (PDF FORMAT)
- **2 SCANNED PASSPORT SIZE PHOTO IN WHITE BACKGROUND**
- **VACCINATION CERTIFICATE (DOUBLE DOSE Approved by GOI)**
- After Scrutiny of the final selected applications DNH FA will be uploading the final selected players list who are eligible to attend trials & list of selected will be uploaded on WWW.DNHFA.COM in the Latest news section on 3rd NOVEMBER 2021 Post evening.
- NO TA & DA will be provided by DNH FA on attending trials.
- Player must carry his N-95 mask & 100ML sanitizer along with him during trials & maintain social distancing.
- We, also wish to inform the teams that the conduct and punctuality of the players coming for trials will be of utmost importance and any player found to be not following the stipulated time will not be considered for the final selection list of 20 players.
- we ensure to maintain all protocols and SOP as issued by the Government while conducting the trials and the camp.
